





# **Operation Round-Up** & Butler REC **Need Your Help**



Operation Round-Up is a program that helps Butler REC enhance the lives of the less fortunate in our community and also helps area charities and service

organizations.

Through this program, Butler REC automatically rounds up a participating member's electric bill to the next highest dollar, with the additional cents going to the Operation Round-Up Fund. In 2011, 4,003 out of our 7,036 accounts participated in Operation Round-Up. Through their generosity, donations of \$24,681.70 were added to the fund, an average of \$6.17 per account.

This past year, the Operation Round-Up program awarded over \$24,188.91 to help individual members and organizations within Butler REC's service territory.

Butler REC members helped support the Butler Homeless Initiative. YMCA Strong Kids program, American Cancer Society, Big Brothers Big Sisters, Butler County Sheriff's Office, NRECA International Linemen's Fund, The Purple Cow Farm, B.A.S.E., local 4-H clubs, National Child Safety Council, OK Kid's Day, Pass it on Program, KARL, Inc. and local high schools.

The program was able to directly help 42 member families with medical bills, house fires and other special circumstances.

#### How to Cast Your Vote for Board of Trustees by Proxy

A member may vote by proxy executed in writing, signed by the ember giving the proxy. Such proxy shall be filed with the Secretary at the time it is voted at any meeting. No proxy is valid after sixty days from the date of its execution.

No proxy is valid unless it specifies the meeting at which it is to be voted, and no proxy may be used for any other meeting than the one designated herein or an adjournment

thereof. A member may give his proxy only to another member, or to an adult relative living in the same home, and no member may hold or vote more than one proxy.

The presence of a member at any meeting revokes any proxy he may have previously given. The minutes of every meeting shall contain a list of the members represented by a proxy, and the name of the person to whom the proxy is given to be voted.
