**SERVICE CONTRACT WITH THE BUTLER RURAL ELECTRIC COOPERATIVE,
ASSOCIATION, INC., EL DORADO, KS**

The undersigned (hereinafter called the "Applicant") hereby applies for electrical service and agrees to purchase electrical energy from The Butler Rural Electric Cooperative Association, Inc. (hereinafter called the "Cooperative") upon the following terms and conditions:

1. When the Cooperative makes electric energy available to the Applicant, Applicant agrees to purchase from the Cooperative and pay monthly to the Cooperative for all electrical energy used on premises described below now owned or occupied by the Applicant at the rates and upon the terms as set forth in Schedule _____ established by the Cooperative and agreed upon by the Rural Electrification Administration of the United States of America and filed and approved by the State Corporation Commission of Kansas. If the applicant's load changes and the above rate schedule is not adaptable thereby requiring a reclassification, the appropriate rate schedule will be applied.
2. The applicant hereby grants the Cooperative the right and easement to construct, operate, repair and maintain on the premises herein described, and in or upon all streets, roads or highways abutting said premises, its electric distribution and service lines and appurtenances, and also the right to cut or trim trees necessary to keep them clear of all parts of the electric system. The lines serving the premises of the Applicant beyond the Cooperative's meter is owned and maintained by the Applicant and shall be kept in a safe condition, free of trees or other hazards.
3. The Applicant will cause his premises to be wired in compliance with the latest edition of the National Electrical Code and approved by the Cooperative. In supplying service to the Applicant the rules and regulations relative to the extension of lines and supplements thereto on file with the State Corporation Commission of Kansas will govern. If a provision on the rules is in conflict with the provisions of a rate schedule, the specified provision of the rate schedule will prevail.
4. The Applicant will comply with and be bound by the provision of the by-laws and rules and regulations of the Cooperative as may be adopted from time to time.
5. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall remain in force for _____ from the date service is made available by the Cooperative to the Applicant, provided the line extension is single phase, 120/240 volts and not more than ¼ mile in length and continue thereafter until cancelled by written notice given by either party to the other at least thirty (30) days in advance. In the event the line extension exceeds one quarter mile (1/4), the minimum monthly bill will be increased according to the provisions of the line extension policy and remain in effect for five years. For other single phase service, contract period shall be stated in contract.
